Human Resources

Two issues to discuss:

- 1. Number of employees below mid-point of the pay range
- 2. Starting salary of level 8

The City has a performance-based compensation plan. For the model presented to us by CBIZ to be effective several processes should be reviewed. The salary compression of our current plan developed over years of time. The following are my recommendations to correct the current compression and alleviate the problem in the future:

- Adjust the pay plan structure the recommended 3.83% budgeted in 2022
- Move employees below minimum to minimum for each pay plan level budgeted in 2022
- Increase the premium added to the merit increase percentages City wide.
 - o 3.83% will add an additional \$59,000 to the budget plus retirement and payroll taxes (15%)
 - o 5.00% will add an additional \$98.000 to the budget plus retirement and payroll taxes (15%)

12 employees with 2 to 4 years in position

17 employees with 4 to 8 years in position

16 employees with 9+ years in position

- Staff will focus closely on all elements of the pay plan:
 - o How long it should take to meet the mid-point of a pay level
 - o Should current employees' salaries be adjusted when pay plan levels for a position change
 - o Consider starting salary range based on experience
 - o Keep pulse with immediate surrounding employers starting wages

Department Comments and Recommendation:

The purchase of the pumps, electrical panels, and communication equipment needed for this project were approved for purchase at the 08/19/21 Board of Aldermen meeting. The attached contract is for the installation of this equipment.

The City received three bids for this work. The bid tab and the winning bidder's bid form are attached. Meyer Electric was the low bidder. The City has worked closely with Meyer Electric for a few years now. They are the City's current street light and signal

maintenance repair contractor. We have a good working relationship with them and see no problem with them doing this work.

Stations being rehabed:

Huff N Puff = 2 new pumps/new 3 phase panel/wet well mixer/transducer control system with floats.

The Ledges = New pump/new single phase to three phase conversion panel/New cellular Scada system/wet well mixer/transducer control system with floats.

Indian Point= 2 new pumps/new 3 phase panel/wet well mixer/transducer control system with floats.

Additional Notes:

The Ledges = Traditional scada will not work in this location. Instead, we will use cellular scada. After the first year, there is an ongoing yearly budget impact of \$360.00 for the cell service.

Even though we took steps to order all the equipment needed well in advance, we are still having issues with getting it all delivered timely. At this time, it is unlikely that this work will be done by the end of the year. Work will likely begin in January once all the parts and pieces arrive.

I recommend Approval.

Department Comments and Recommendation:

This is a change to section 510.030; Procedures for accepting new streets into City inventory. This bill currently states that all roadways must go through the Planning Commission for approval before they are forwarded to the Board of Aldermen for approval. I am proposing a change to this ordinance that would allow certain roadways to by-pass the Planning Commission when they meet the following criteria.

- 1. The street meets city design guidelines or design guidelines have been waived by the Board of Aldermen,
- 2. The street has been previously created on a plat by the Recorder of Deeds for Miller or Camden County,

3. Construction improvements were previously approved by the Board of Aldermen.

As stated in red on the attached document, in order for a street to by-pass the Planning Commission and come straight to the Board of Aldermen for approval, all three of these conditions must be met.

I recommend approval.

This is a requested change in ordinance related to circumstances that have materialized recently regarding acceptance of certain roadways, under specific conditions. I concur with the department's recommendation.

AN ORDINANCE OF THE CITY OF OSAGE BEACH, MISSOURI, AMENDING SECTION 510.030 OF THE CITY ORDINANCES, TO CREATE PROCEDURES FOR ACCEPTING STREETS INTO THE CITY PUBLIC ROAD SYSTEM, DIRECTLY BY THE BOARD OF ALDERMEN WHEN CERTAIN CONDITIONS HAVE BEEN MET.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF OSAGE BEACH, AS FOLLOWS:

<u>Section 1</u>. That Section 110.300 is hereby amended with amendments as set forth below with new material set out in red to read as follows:

- A. All applications shall be submitted on forms provided by the City.
- B. All applications shall be reviewed by the Planning Commission and forwarded to the Board of Aldermen with their recommendations.
- C. Exceptions: Roads considered for acceptance into city inventory are not required to go through the Planning Commission for approval and may be brough directly to the Board of Aldermen for approval when all the following conditions are met:
 - i. The road meets city design guidelines standards, or the Board of Aldermen has previously waived application to city design guideline standards for the road in question,
 - ii. The road has been previously created in a plat recorded with the Recorder of Deeds for either Camden or Miller County,
 - iii. The construction improvements have previously been approved by the Board of Aldermen.
- D. The Board of Aldermen shall direct the City Clerk to schedule a public hearing for the purpose of receiving comments concerning the application.
- E. After consideration of the comments and documentation received during the public hearing, the Board of Aldermen may approve the application if they are of the opinion, it is in the best interest of the city.

Section 2. Severability

The chapters, sections, paragraphs, sentences, clauses and phrases of this ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconstitutional or otherwise invalid by the valid judgment or degree of any Court of any competent jurisdiction, such unconstitutionality or invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, or sections of this ordinance since the same would have been enacted by the Board of Aldermen without the incorporation in this ordinance of any such unconstitutional or invalid phrase, clause, sentence, paragraph or section.

Section 3. Repeal of Ordinances not to affect liabilities, etc.

Whenever any part of this ordinance shall be repealed or modified, either expressly or by implication, by a subsequent ordinance, that part of the ordinance thus repealed or modified shall continue in force until the subsequent ordinance repealing or modifying the ordinance shall go

into effect unless therein otherwise expressly provided; but no suit, prosecution, proceeding, right, fine or penalty instituted, created, given, secured or accrued under this ordinance previous to its repeal shall not be affected, released or discharged but may be prosecuted, enjoined and recovered as fully as if this ordinance or provisions had continued in force, unless it shall be therein otherwise expressly provided.

<u>Section 4</u>. That this Ordinance shall be in full force and effect from and after the date of passage and approval of the Mayor.

During the Citizen's Comments at the November 4, 2021 Board of Aldermen meeting, Michael Harmison, owner and operator of Harmison's Hometown Fundraising and Harmy's Cheese Store, spoke to the Board of Aldermen about his current situation regarding Certificate of Occupancy, requesting the Board to grant "an 18-month temporary occupancy permit". Mr. Harmison currently has a temporary Certificate of Occupancy valid through November 19, 2021, issued by the Building Official.

Following Mr. Harmison's comments at the November 4, 2021 Board of Aldermen

meeting, the Mayor directed Mr. Harmison to contact the City Administrator and arrange the request to be included in an upcoming Board of Aldermen meeting agenda.

Direction by the Board of Aldermen may be necessary in such circumstances beyond department/staff authorization. Unless specifically outlined in the City's Code of Ordinances, authority of the City Administrator, department management, or other City staff is limited to the perimeters of the City's Code of Ordinances.

Good evening. My name is Michael Harmison, and I am the owner of Harmison's Hometown Fundraising and Harmy's Cheese Store and more located right down the road on the West End of Osage Beach in Ward 2. I am asking that tonight an Alderman will make a motion, a 2nd Alderman will 2nd the motion and it is voted on to grant me an 18-month Temporary Occupancy Permit for my new 6,000 square foot building behind Harmy's Cheese Store. I am asking for this permit to serve as occupancy for the storage of and shipping of Fundraising & Cheese Store items, cold and frozen rental storage as well as utilizing a 2,400 square foot area for assembly of no more than 100 people.

After living in lowa for most of my life, I moved to Osage Beach and purchased this property in May of 2014 and opened Harmy's Cheese Store & More in May of 2015 on what many call "The Dead End" of Osage Beach. I also operate Harmison's Hometown Fundraising out of this same property. I have been in the Fundraising business for 32 years and pre-covid, Harmison's worked with around 300 non-profit organizations nationwide by providing them with cheese, sausage, snacks, cookie dough and other various items to sell to earn needed funds. Most of our customers are the FFA organization, formally known as Future Farmers of America whose colors are prominently known as Blue and Yellow. My nickname in college was Harmy and that is the short history of how Harmy's cheese store got its name and why the colors are blue and yellow. This year Harmison's is on track to work with around 160 organizations nationwide and post covid we will only continue to grow, and Harmy's Cheese Store is consistently setting sales records year after year and has truly become a destination area for vacationers and a regular shopping store for locals.

It was my hope and plan that both businesses would thrive and grow and be a leader of turning the so called "Dead End" into a flourishing area once again. I believe this is happening and why I decided to invest 3 quarters of million dollars into the new facility. The new facility is phase 1 of a 2-phase plan with the second phase being a new Harmy's Cheese Store built connected to this facility and the existing Harmy's coming down and that entire area paved all the way to the business 54 for plenty of parking and allow us to solicit tour bus agencies for trips to Harmy's and Osage Beach. The current Harmy's has a footprint of 1,000 square feet and the new Harmy's is estimated at 2,400 square feet. It is my intention to have this 2nd phase completed for a Grand Opening Memorial Day 2023.

At the completion of the facility, occupancy was denied because the parking area was not paved or concreted per city code. Unfortunately, I was not aware of this code and after learning of the code hoped that since this was only the completion of the 1st phase and that much of the 2nd phase (The new Harmy's Cheese Store) would be built on top of the paved or concreted area that the City of Osage Beach would grant me an 18 month, either variance or at least a temporary occupancy. This made sense to me knowing that both businesses were successful, and that success was financially contributing to the Osage Beach.

I simply had to keep Harmy's open during the summer tourist season and with fundraising starting up in the Fall, I explained to several employees and elected officials of Osage Beach that I really didn't want to spend \$25,000.00 on pavement that I would have to tear up in a year and that I couldn't close for a week while the payment was being installed. To my surprise and disappointment, I was ultimately told that the only way for me to receive a Temporary Occupancy that I would have to have plans drawn up and approved by the city and that I sign off on the project to install pavement. I followed all the requirements placed on me and contracted with Capital Paving to install the necessary area and committed to paying approximately \$25,000.00 in pavement that will need to be removed for the completion of the new Harmy's in the next 18 months. This Temporary Certificate of Occupancy is only valid until 11/19/2021 and I am still waiting to hear when this project can be completed because of they are currently so back logged.

As you can see by these photos, the current parking and driving area is highly efficient for both vehicles as well as walking. The ramp shown here allows for vehicles to be driven inside the facility for letting out and picking up those with special needs. You can also see plenty of parking space to the side and in front of the new facility as well as in front of Harmy's and a circle drive for entering and exiting. You can also see the area of the existing Harmy's that will become a parking lot with plenty of parking. Inside this facility there is an 854 square foot refrigerator, an 854 square foot freezer, 2 loading docks, 3 stall woman's restroom (ADA Compliant), 1 ADA Compliant men's stall and 2 urinals. I invite all of you to come out for a personal visit to see this beautiful facility. Please feel free to call me on my cell at 515-991-3214.

The building was designed and built to be used for the fundraising business from October through December with about 75% of our business taking place at that time. Our coolers are filled with cheese and sausage and the freezers are filled with cookie dough. The middle 2,400 square foot area is where we pack school orders, and the loading docks are for shipping. During the non-fundraising season, the plan is offering the only cold and frozen storage facility for rent in this area. We have had lots of interest from restaurants and bars so that they can order frozen product in bulk during the off season to save money and avoid shortages, store at our facility, and come get what they need as they need during the summer. I have also been approached by a Budweiser distributor out of Lebanon about renting the cold storage during the summer month rather than making the trip from the lake back to Lebanon on a regular basis. This building is certainly unique for this area and offers much to the community.

So again, I am asking that tonight an Alderman will make a motion, a 2nd Alderman will 2nd the motion and it is voted on to grant me an 18-month Temporary Occupancy Permit for my new 6,000 square foot building behind Harmy's Cheese Store. I am asking for this permit to serve as occupancy for the storage of and shipping of Fundraising & Cheese Store items, cold and frozen rental storage as well as utilizing a 2,400 square foot area for assembly of no more than 100 people.

I absolutely love living in Osage Beach and at the beautiful Lake of the Ozarks and will live here for the rest of my life. I am involved in many local organizations and both of my companies have contributed finically to the city as well as local charities. I have several ideas and plans to help make the West End and Osage Beach Great Again and asking for your help tonight. Thank you.
