-City of Osage Beach-Board and Commission Vacancies

Osage Beach, MO – The City of Osage Beach has vacancies for the following boards and commissions.

- <u>Board of Adjustment</u> The Board of Adjustment consists of five City resident members who serve five-year terms; currently one Board seat is vacant. Members are appointed by the Mayor and approved by the Board of Aldermen. Alternate members may be appointed to serve in the absence of regular members. The Board of Adjustment approves or denies all variance requests and appeals in matters relating to the zoning code requirements. The Board of Adjustment meets as needed and as called by the Chairman of the Board of Adjustment or by the Board of Aldermen. When called to meet, the meetings are held at City Hall on the third Wednesday of the month, 4 PM.
- <u>Planning Commission</u> The Planning Commission consists of at least seven, but no more than fifteen, City resident members who serve four-year terms; currently three seats are vacant. Members are appointed by the Mayor and approved by the Board of Aldermen. The Planning Commission acts as the Zoning Commission for the City and adopts, reports, and make recommendation to the Board of Aldermen on matter relating to the adopted Comprehensive Plan, uses of land, the physical development of the City, and other matters promoting municipal planning; in addition, serves as an advisory body to the Board of Aldermen on matters related to City growth and development, and other issues as requested by the Board of Aldermen. The Planning Commission meets the second Tuesday of each month, 6 PM, at City Hall.

Osage Beach residents wishing to be considered for either board or committee listed above should send a signed and completed *Osage Beach Board/Commission Application* to the City Clerk, for Mayor Harmison's consideration, by **Monday, December 11, 2023, 5 PM,** as follows: (application is enclosed and available at www.OsageBeach.org)
