City of Osage Beach UPDATE #2 ATM Burglary – 10:00 a.m. 1/30/2025

**Osage Beach, MO** – On 01/29/2025 at 2:32 a.m. Officers responded to Oak Star Bank located at 5127 Osage Beach Parkway for an alarm sounding. When Officers arrived, they found a Ford pickup truck unoccupied with a chain attached to the bumper. Officers noticed the ATM had been forced open and an undisclosed amount of money was taken. Officers later learned the truck was stolen locally. Upon reviewing video surveillance, it was determined there was another vehicle involved which was later identified as a Hyundai Tucson.

A search of the Flock License Plate Reader System (LPR) identified a Hyundai SUV bearing Minnesota License plate KMH808 traveling through Eldon towards Osage Beach on Highway 54 prior to the burglary. The image was captured by a Missouri Department of Public Safety LPR. Investigators learned that the vehicle was rented to Monique Richardson from Missouri City, Texas and was due back on 01/29/2025 to Enterprise Leasing out of Missouri City, Texas by 1:00 p.m.

Osage Beach Detectives began working on identifying the travel path of the vehicle; while doing so, they learned the vehicle passed another LPR near Pryor, Oklahoma. This allowed Osage Beach Detectives to start notifying agencies along the suspected travel path of Highway 69/75. Officers in Durant, Oklahoma observed the vehicle traveling through their jurisdiction and attempted to stop the vehicle, and when doing so the vehicle fled from the officers. Officers were eventually able to stop the vehicle and take all subjects into custody.

There were several items found in the vehicle including a total of \$47,315.00 in cash. \$11,440.00 was stolen from the Oak Star Bank in Osage Beach.

The subjects are identified as Tyrese D. Holloway 24 from Houston, TX, Augustus C. Sherman 24 from Houston, TX, Mylek M. Freeman 24 from Missouri City, TX and Christopher Delasbour 26 from Missouri City, TX.

Probable Cause statements were filed with the Camden County Prosecutors Office and warrants were issued on all subjects for Stealing over \$750.00 and Stealing a Motor Vehicle with no bond. All the subjects are currently held in the Bryan County Jail in Oklahoma. The Osage Beach Police Department investigation is ongoing, and updates will be issued as new information becomes available.
